- *6 installments due from July 15th - December 15th*
- August 1, 2025: **Payment Due for Fall 2025 semester, including Session I**

- *All international students are required to make a min. payment of \$2,000 towards their Fall bill to proceed with classes*

 - Applies to NEW undergraduate students only
- February 6, 2026: **Deadline to Waive the Spring Student Health Insurance**
 - Applies to NEW students only
- Late February-March 2026: **Spring Refunds are Produced**
 - Refunds produced within 14 days following disbursement of financial aid
